

FSMA Timeline Update

- **Produce Safety**
 - October 31, 2015
- **Preventive Controls**
 - August 30, 2015
- **Imported Food**
 - October 31, 2015
- **Food Transportation**
 - March 31, 2016
- **Intentional Adulteration**
 - May 31, 2016



PSA Training Plan

- Plan to conduct train-the-trainer workshops as soon as we can
- Plan to train (and certify) growers as soon as we can
 - This means before the rule is final
 - Follow up with them if something is different



Proposed Produce Rule Training Requirement

- Proposed § 112.22(c) would require that at least one supervisor or responsible party for your farm successfully complete food safety training at least equivalent to that received under standardized curriculum recognized as adequate by the Food and Drug Administration.

Competency 2:

Agricultural Knowledge and Experience

- Ability to apply scientific information to real-world agricultural situations
- Educational credentials and professional certifications



Competency 3: Effective Training Delivery

- Ability to present and explain technical scientific information
- Exceptional public speaking and verbal skills
- Ability to organize and evaluate training programs

Working Committee #8: Train-the-Trainer

- Effective adult education
- Standardized content, consistent messages
- Meet needs of diverse audience
- Pre-training survey to assess knowledge gaps of trainers
- Tailor to meet regional/commodity needs



Working Committee #8: Train-the-Trainer

- Ease of trainer access to materials and continuing education
- Emphasize importance of writing a FSP
- Focus on science-based risk assessment
- Must address grower's pre-conceived notions about food safety
- Must convey a positive message and empower growers to implement practices
